Committee Meeting Minutes 17th Feb 2010

Discussion

1. Open Meeting

- ◇ Registrations to be completed on the night for teams
 - i. Any team not sending a representative will have penalty applied.

2. Rescheduled matches

- ◇ Claire has confirmed all venues
- ◇ Lost 2 nights in total but all rescheduled matches are up on the web site.
- ◇ Arrange contingency in case of more bad weather although looking unlikely.

3. Issues Arising

- ◇ Psycho Physio's – registered player not eligible to play for the play offs. In breach of the playing up rule – penalty applied
- ◇ Note – update rules to reflect that notification needs to happen when transferring players – Laura to write content and send from the Live Account.
- ◇ Psycho Physio's - Unaffiliated players – played once not affiliated to E unless confirmation is received by the Open Meeting then penalty will apply – no confirmation received.
- ◇ Psycho Physio's - Not phoned through results or emailed – penalty applies (Div 1 Rota)
- ◇ All three points are to be addressed to Psycho Physio's in email.
- ◇ Connexions v Crendon – discrepancy on score. Umpires and scorers decision was made and upheld by the committee as they are officials of the match. Sonia to email back response to both clubs.

- ◇ Note at the Open Meeting regarding the importance of scorers and requirement for them to complete that role to the best possible standard.
- ◇ All Blacks v Cherokees – behaviour and language concerns raised by divisional rep. All Blacks have reprimanded player and advised that if it continues further action will be taken. Apologies were made at the time. Matter resolved.
- ◇ Confirmation of rule query. You must have 5 players to play a match but they can be players that have played up within the restrictions set out in the ADNL rules.
- ◇ Quainton Blades – not phoning through results. Ability to communicate results via phone or other member of team. Sally to email club – penalty applied.
- ◇ Div 3 20/01/2010 – complaint regarding umpiring from team in the league. Review of umpiring by committee to be completed and mentoring to take place to improve standard.

4. AOB

- ◇ Transfer deadline - Laura notified that all transfers after the deadline are not eligible to play in the play offs. This will be checked at the play offs with all teams involved.
- ◇ Rule change – penalty to be applied if registration forms are not completed accurately and on time.
- ◇ Court Fees – all paid
- ◇ Trophies – need to be taken to the Open Meeting or Div reps.
- ◇ 2 teams now applied to join the league – to be advised as to options once all registrations are completed.
- ◇ Seeding – considerate of teams in the league however the committee is keen to encourage the development of the league and the teams within the league by teams of a high standard.
 - i. These teams are able to request seeding on application.
 - ii. Proposal for Rule change – 2 bottom teams play off in bottom league to go out of the league if the league is full.
- ◇ Note to clubs – Sonia to respond to clubs:
 - i. score cards and sheets need to be written up by previous rota.
 - ii. If scorers don't turn up umpires to score – scorers compulsory next year (rota rule amend required)
